HOW TO USE THE EQUIPMENT

General description:

Bench for hyperextension chest training. The legs-support is adjustable in vertical and horizontal, to allow everybody to find a correct position to make the exercise. Planned for professional use, it has a very good stability guaranteed by the frame structure. It can be used for horizontal back extensions and a 45° back extensions.

Muscles involved:

Lumbars;

Movements and position:

Choose the right inclination of the bench using the specific knob. Come up the bench, putting feet on the footrest, adjusting the height of the supports for pelvis and legs. Cross the hands behind the head and, keeping the back straight, come down until maximum contraction; therefore come up, not extending body completely.

Safety rules:

- Keep away other people during the movement;
- Do not make sudden movements and stabilize the phase of return;
- Use a correct load, do not exceed;

BREAKDOWNS AND MAINTENANCE:
